Large spill

#### 8.2 Exposure controls

Appropriate engineering controls

 Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

### **Individual protection measures**

**Hygiene measures** 

: Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. # Eye/face protection Skin protection

**Hand protection** 

: Safety glasses with side shields. Use eye protection according to EN 166.
